Rocky Mountain Chapter North American Versatile Hunting Dog Association Chapter President's Address August 20, 2022 6:00 p.m.

RMC Chapter Members,

As this weekend comes to a close with the last day of the fall test upon us, so too does our 2022 training season. For those that tested this year I hope your training efforts paid you back with a successful test result. If you didn't test this year, I hope your training efforts have resulted in some extra polish on your dog and have you excited to hunt with that dog in the field this hunting season.

The chapter continues to grow and fulfill its mission of fostering, improving, promoting, and protecting the versatile hunting dog breeds in North America. Our chapter continues its steady growth in membership, and it is encouraging to see new members join us, with new puppies and no background in hunting, but especially the younger members taking the reins of their first dog and progressing, with great results, up through the NAVHDA system; if the sport of hunting is to continue, it needs an infusion of both adults new to the sport and youth wanting to learn about dogs and their application to hunting.

But growth in any endeavor is not without challenges. For our chapter this has meant addressing the training needs of more people without a corresponding increase of time available to get it done. The chapter, namely Training Director Sara Heesacker and her able Assistant Jake, has developed flexible, innovative, and creative ways to get handlers new to dog training in general, and those new to NAVHDA, the exposure and repetitions the new handlers and dogs need in order to have successful test results, and maybe most importantly, have success in the field.

Having said that, training for a test is, in some ways, pointless if there is no opportunity to test a dog. The NAVHDA International Board discussed this issue during the NAVHDA International Annual Meeting last January. NAVHDA International is also seeing steady growth annually but is not seeing a corresponding increase in the number of tests conducted. To address this, NAVHDA International has a program to provide funding to help new chapters get established, in the hopes that those new chapters will then make available opportunities to test.

Obviously, new chapters don't directly help our chapter. Our chapter is addressing this problem by adding an additional test weekend next year. Efforts have begun to organize an additional test during the month of June. The dates have been discussed by the Board and will be voted on this evening.

Of course, adding an additional test doesn't happen without financial considerations. This year the Board of Directors formed a Budget Committee to assist the Board in addressing the financial matters the chapter faces, both the anticipated short-term expenses, and to establish financial plans for issues that may affect the chapter in years further out. The Budget Committee will be heavily involved in the planning of next year's tests and other chapter activities. Looking further out, the chapter needs to be ready for a day when we've outgrown Cobb Lake SWA, and the Budget Committee will help the chapter with the tasks that may come with that development.

Continuing to look towards the days ahead of the chapter, it is exciting to know we have a new board position starting this year that will help develop the interest in hunting dogs within the young people of the chapter. I am excited to see where this program will go with the help of NAVHDA International and our soon-to-be new Director of Youth Development.

I believe in the last year the chapter has responded well to its continued growth, has taken steps to address the challenges that come with growth, and is poised to continue to meet the needs of the members, including the younger future members, for some time to come.

Section 1: The *Rocky Mountain NAVHDA* Board of Directors shall consist of 4 elected officers (President, Vice President, Treasurer, and Secretary), and 5 *appointed* directors (Director of Training, Director of Judging, Director of Promotions and Fundraising, and Director of Youth Development). In the event that a directorship is shared between two people there will be only one board vote for that directorship.

Section 2: Board members are expected to participate in all Chapter Board meetings. If a Board member is unable to attend the Annual Meeting, he or she may designate the President to offer his or her vote by proxy.

Section 3: Board members are expected to participate at tests, training days, clinics and other events at least but not limited to the capacity of their position. If a board member is unable to attend an event, it is the sole responsibility of the board member to assign a qualified chapter member to fulfill their duties at the event.

Section 4: At least one member of the Board of Directors, or an appointee by the President must attend any test, clinic, training day or other event sponsored by the Chapter.

Section 5: If a Board member resigns, or is unable or unwilling to perform the duties of the position, he or she may be replaced during the calendar year by a majority vote of the Board.

NOMINATIONS:

Section 1: On July 1st of each year, but not later than July 15th, the Secretary will announce to the membership that nominations for expiring board positions are open. This communication shall include a list of all current Board Members and the expiring dates of all terms.

Section 2: The President, with advice and consent of the Board of Directors, can appoint a nominating committee. The recommendations of the nominating committee will be published on the website along with all other nominations prior to the election.

Section 3: Nominations will be accepted by the Secretary from the Membership until July 31st. Members may nominate themselves. Members who are not nominating themselves must agree to accept the nomination which is to be verified by the Secretary. One person may be nominated for more than one office; however, that person may only serve in one office at a time.

Section 4: Any voting member in good standing is eligible to hold office. A member in good standing must:

1. Have dues paid and been a chapter member for 1 full calendar year.

- 2. Attend meetings regularly.
- 3. Participate in Chapter activities, including training and testing.

ELECTIONS:

Section 1: Elections for the 4 elected officers shall be held annually at the time of the Chapter Annual Meeting.

Section 2: Each chapter member in good standing with voting rights shall be entitled to one vote for each office. The order of the voting may be decided at the discretion of The Board.

Section 3: Elections may be accomplished by visible hand count or secret ballot at the discretion of the Board. The results of such election, as determined by a plurality of the votes, shall be made known at the annual meeting.

Section 4: Election Terms: Terms of an office shall be two years and shall begin in the election year for that office on the day of the Annual Meeting and shall expire on the subsequent election year for that office on the day of the Annual Meeting.

Even Years: President and Secretary

Odd Years: Vice President and Treasurer

Section 5: Officers shall be elected to a particular office for no more than (2) <u>consecutive</u> 2-year terms.

Section 6: Placement of Appointed Directors: Director positions (Judging, Testing, <u>Training</u>, Promotions, and Youth Development) are appointed by the Elected Officers to one-year terms at the Annual Meeting each year. Terms will begin on September 1st.

Section 3: No member shall hold the same position for more than 4 consecutive terms unless a replacement is unavailable.
